
navigating the complexities of per- and polyfluoroalkyl substances (PFAS) management within their unique systems.

State of Massachusetts Bridge Academy Training Reimbursement Grant Applications Open Through June 30

Massachusetts communities that have had one or more police officers complete the Bridge Academy Training Program are eligible to submit for reimbursement a portion of the costs of having an officer become trained. The total amount available this year is \$3,000 per officer.

Officers must complete four courses, including firearms training, defensive tactics training, emergency vehicle operator training and online curriculum and testing.

Applications for reimbursement will be accepted on a rolling basis until **June 30**, **2024**, however there are limited funds available, so towns are urged to apply as soon as their officers have completed the necessary training.

Massachusetts Office of Travel and Tourism Accepting Applications for Destination Development Capital Grant

Funding

The Massachusetts Office of Travel and Tourism is now accepting applications for the **Destination Development Capital grant**, which awards up to \$6 million to selected communities whose projects will enhance tourism resources and infrastructure and will aid in climate resiliency. The grant is focused on capital improvements with a direct relationship to tourism, and other physical/structural items with a greater than five-year lifespan. Projects with a presence in a designated cultural district, locations within rural communities, and a nexus with commemorations of the 250th anniversary of American Independence may receive priority consideration.

The application deadline is 3 p.m., on Friday, May 31, 2024.

DOJ Announces COPS Hiring Program Grants

The U.S. Department of Justice is providing grant funding for its FY24 **COPS Hiring Program**. The grant funds are directly available to law enforcement agencies to hire additional career law enforcement officers, enabling municipalities to increase their community policing capacity and crime prevention efforts.

Interested applicants must submit their application in a two-step process after getting a required Unique Entity Identifier (UEI), which can be obtained by visiting the **Sam.gov website**. Applicants will then need to submit a SF-424 and a SF-LLL form to the **Grants.gov website** by Thursday, June 6, 2024. The full application deadline including attachments is due Wednesday, June 12, 2024, at **JustGrants**.
