This competitive grant program assists municipalities in constructing or completing municipal fiber networks. It supports centralized IT management, cybersecurity, and disaster recovery. To apply, municipalities must submit a detailed project proposal, including project purpose, budget, and impact. A 5% local match is required, which can be in-kind services. We coached the Town in developing the budget and gathering the information needed to submit a competitive application, and utilized that to submit the grant on their behalf. The Town was awarded over \$172,000 to install fiber optic cable to network four critical town buildings.

The Massachusetts Department of Environmental Protection State Revolving Fund solicitation for new 2025 drinking water and clean water projects deadline is approaching.

MassDEP's Division of Municipal Services is accepting Project Evaluation Forms for construction projects, asset management planning, and Sewer Overflow and Stormwater Reuse Municipal Grants, through July 26 at noon, for consideration in the calendar 2025 funding cycle.

To apply, submit a PEF **online via MassDEP's website**. MassDEP is also accepting loan/grant applications for new projects, on a rolling basis.

State of Massachusetts Cool Corridors Tree Planting Grant Applications Open Through August 2

Massachusetts communities can beat the heat with the **FY25 Cool Corridors Tree Planting Grant** opportunity offered by The Executive Office of Energy and Environmental Affairs (EOEEA) that supports community based tree-planting initiatives.

The program targets reducing temperatures and saving energy costs by adding plantings within neighborhood walking routes, specifically near schools, daycare facilities, transit stops, elderly care facilities & medical facilities.

Eligible applicants are encouraged to consider opportunities to partner, leveraging the unique abilities of each to achieve the greatest impact on mitigating urban heat while ensuring the watering and care of shade trees planted for a two-year period with a focus on the principles of the "right tree, right place" concept.

Applications are due by 4 p.m. on Friday, August 2, 2024.
